**@Emma:** Thank you very much for your prompt professional response. I added **@Anne Marie** plus previous **@Township Authorities** back for important final thoughts in my last email of *this* thread.

MDOT smugly shares a previously unreleased 'secret' document proving Tetraethyl Lead (TEL) is safe and no danger to anyone after almost six full years 'under MDOT protective wraps'. Perhaps MDOT should be applauded for their 'transparency' even at this late date, even after half a decade? NO, not really, there is ZERO MDOT transparency period.

"Share" isn't the right term. MDOT never shares or provides anything to the general public by default. MDOT likes to opportunistically 'brandish' reports based on MDOT timing, convenience & advantage generated from tried & true Professional Airport Mercenary boilerplate templates that have been refined & utilized over & over to successfully bully, obfuscate, delay, deceive, mislead & lie. This is MDOT typical behavior demonstrated utilizing years & years of Special Interest & Industry Lobbyist expertise.

The MDOT report in question: "Preliminary Site Investigation Report. Canton-Plymouth Mettetal Airport, Wayne County, Michigan. Prepared For: Michigan Department of Transportation, Lansing, Michigan. Project No. 181278 October 4, 2018". BTW: thank you Emma, *this* report that MDOT implies "Provides Proof" that Tetraethyl Lead (TEL) "does not appear to be a health risk" will be shared for public scrutiny via web site & Youtube channel.

The MDOT Project Report No. 181278 "Executive Summary" on page 1 states "Ground Water was not encountered." This is patently false and is a complete unadulterated lie. I will personally testify in any US Court under oath to this effect. What the "report" doesn't say that was publicly reported back in 2018:

On Monday September 10, 2018 and Tuesday September 11, 2018 a survey crew subcontracted via FTC&H, now just "Fishbeck", was at 1d2. "Michigan just had the wettest water year in 119 years of records. Anyone could see 'samples' taken in standing water, anyone within .5 km could see that MDOT hired teams armed with highly advanced precision fence post augers mounted on the back of old model rusty pickup trucks that were literally dripping mud & water! Just ask the third-party service that performed the MDOT's highly technical sounding field work. This was not high-end certified laboratory work with people in white lab coats like in the movies, quite an amateur operation at best."

Repeatedly flooded airstrip grounds, and all of Canton Township flooded for that matter, coupled with on-going "grounds maintenance" and a complete airstrip runway restoration & paving project in late 2020 with significant ground disturbance, movement & redistribution of sandy fill dirt, which included a lengthy extended complete airstrip shutdown certainly casts doubt on the efficacy of the MDOT testament: "Does Not Appear to Be a Health Risk". Is this how the Canton Community Health, Safety & Welfare are being protected backed up with statistical dirt reports that ridiculously project the "appearance" of Tetraethyl Lead (TEL) NOT being a Health Risk?

Furthermore, the MDOT Project Report No. 181278 reports that Tetraethyl Lead (TEL) certainly WAS detected in 2018, but THAT fact is NO big deal, move along, nothing to see here, cased closed. MDOT Project Report No. 181278 therefore 'proves' it's SAFE to operate aircraft including helicopters burning Avgas AKA 100LL Leaded aviation fuel with Tetraethyl Lead (TEL) less than 500 meters from P-CCS Hulsing Elementary School, or any elementary school in Michigan, or the entire United States for that matter. I will personally forward MDOT Project No. 181278 report dated October 4, 2018 to the EPA & FAA and DEMAND an end to the National Avgas Ban Debacle just because MDOT says it *appears* so.

More "Lies, Damn Lies & MDOT Statistics." MDOT Project Report No. 181278 and all it implies provides absolutely ZERO protection or relief for Canton Community Health, Safety & Welfare period.

Again, early 2023 late 2022 'someone' was very busy boring & extracting yet more 'secret' soil test samples within a square kilometer of the exalted "MDOT 1d2 Frat House". BTW: someone forgot to tell MDOT there's way more to Tetraethyl Lead (TEL) Poisoning than only detecting Tetraethyl Lead (TEL) in washed out flooded areas of sandy fill dirt. While dirt tests might be important for MDOT justification(s) & excuse(s), "Atmospheric Lead Exposure" is an important Key Performance Indicator (KPI). This KPI has been accepted in the scientific community and that "Atmospheric Lead Exposure" at levels 10 times less than NAAQS standards permanently damages humans, including nearby PCCS school children! Especially the Tetraethyl Lead (TEL) PM2.5 shapes & sizes specifically emitted by aircraft including helicopters burning Avgas AKA 100LL Leaded aviation fuel with Tetraethyl Lead (TEL). This is common Aviation & Aerospace Industry knowledge referenced years ago by the US National Academies.

Or perhaps the latest round of dirt sampling is done as a pathetic attempt to ward off or counter any legal challenges or related claims of MDOT incompetence, professional negligence, biased willful neglect, abuse of power, total fiscal irresponsibility wasting millions & millions of Taxpayer dollars or abject acquiescence? Good morning Mr. Grisius,

Thank you for writing in with your concerns. I appreciate that you care for this community and its children. Supervisor Anne Marie reached out to the Deputy Administrator of MDOT Aeronautics to share your concerns. I have attached the report that they shared with us. In summary, the report indicates:

- *The results of this PSI did not identify evidence that the soils in the investigation area have any marked difference in lead concentrations than the soils in the background area. Further, soils in the investigation area do not have lead concentrations that exceed the Part 201 Screening Levels for Residential Direct Contact or Particulate Soil Inhalation Criteria, nor regional background concentrations. Based on the soil-lead concentrations observed, there does not appear to be a health risk to site workers or the public under the current site use conditions*

Voluminous documentation including irrefutable medical & scientific based facts, evidence, data, knowledge & expertise that speak for itself from SMEs such as the US National Academies, detailed studies linking over a Million Michigan Child Blood Lead Levels (BLLs) to 448 Michigan Airports, plus over two hundred pages of supporting 'Comments' submitted to the Environmental Protection Agency (EPA) & the Federal Aviation Administration (FAA), whom you know personally all too well.



I and many others in the Community continue our sadness & disappointment that Canton Township did NOT want to publish or even acknowledge Negative Aviation Impacts (NAIs) seven years ago, and it's even more evident in 2024. Just a continuation of the same Community Disservice of apathy, denial, deflection & avoidance.

It's perfectly clear that the Michigan Department of Transportation (MDOT) owned Canton-Plymouth Mettetal (1d2) airstrip 'exists' literally only for a handful of elite privileged cronies mostly from other communities.

### **Negative Community Outcomes (NCOs) 50 Year History**

The Michigan Department of Transportation (MDOT) owned Canton-Plymouth Mettetal (1d2) airstrip continues to be an unneeded unwanted non-sustainable toxic non-strategic non-mission-critical non-essential insignificant personal hobby sport recreational & social entertainment venue, has never been important to Wayne, Washtenaw or Oakland Counties, and provides absolutely:

- ZERO for Canton Township Michigan residents
